### CONSTITUTION OF INDIA.

No.(GN-110) PARACH-2001-O-3454-GOI-14 (2006)-P.— In exercise of the powers conferred by the proviso to article-309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Gujarat Civil Services (Leave) Rules, 2002 namely:-

- 1. (1) These rules may be called the Gujarat Civil Services (Leave) (Amendment) Rules, 2006.
  - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Gujarat Civil Services (Leave) Rules, 2002, after the rule 69, the following rule shall be inserted, namely:-
  - "69 A. Child Adeption Leave: (1) A Competent Authority may, subject to the provisions of this rule, grant to a female Government employee, with fewer then two surviving children, on valid adoption of a child below the age of one year, Child Adoption Leave for a period of one hundred and thirty-five days immediately after the date of valid adoption on the lines of maternity leave admissible to natural mother.
  - (2) The Leave salary admissible during the period of child adoption leave shall be equal to the pay drawn immediately before proceeding on leave.
  - (3) (a) Child Adoption Leave may be combined with any other kind of leave.
    - (b) In continuation of the Child Adoption Leave granted under sub-rule (1), a female Government employee on valid adoption of a child may also be granted, if applied for, leave of the kind due and admissible (including leave not due and commuted leave not exceeding sixty days without production of medical certificate) for a period up to one year reduced by the age of the adopted child on the date of valid adoption, without taking into account Child Adoption Leave:

Provided that this facility shall not be admissible in case she is already having two surviving childeran at the time of adoption.

(4) Child Adoption Leave shall not be debited against the leave account.".

### CONSTITUTION OF INDIA

No. (GN-114) RJA-2006-O-877-P:- In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Gujarat Civil Services (Leave) Rules, 2002 namely:-

- 1 (1) These rules may be called the Gujarat Civil Services (Leave) (Second Amendment) Rules, 2006.
  - (2) They shall come into force at once.
- 2 In the Gujarat Civil Services (Leave) Rules, 2002, for rule 16, the following shall be substituted, namely:-
  - "16. Maximum Period of Continuous Leave, (1) No Government employee shall be granted leave of any kind for a continuous period exceeding five years.
    - (2) A Government employee shall be deemed to have resigned from the service if, he,-
      - (a) is absent without authorization for a period of one year from the date of expiry of sanctioned leave or permission; or
      - (b) is absent from the duty for a continuous period exceeding five years even if the period of the unauthorized absence is for less than a year.

Provided that a resonable opportunity to explain the reason for such absence shall be given to the Government employee before the provisions of sub-rule (2) are invoked.

No. (GN-3) PARACH-2004-O-1030-P.-In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, the Governor of Gujarat hereby makes the following rules further to amend the Gujarat Civil Services (Leave) Rules, 2002 namely:

- 1. These Rules may be called the Gujarat Civil Services (Leave) (Amendment) Rules, 2007.
- 2. In the Gujarat Civil Services (Leave) Rules, 2002 (hereinafter referred to as "the said rules"), in rule 47, in sub-rule (1), in clause (d), for the words "Superannuation" the word "retirement" shall be substituted.
- 3. In the said rules, in Rule 60,-
  - (i) In sub-rule (1) before the words "Extraordinary Leave" the following words brackets and figure shall be added, namely:-

"Subject to the provisions of sub-rule (5).";

- (ii) after sub-rule (4) shall be added, namely :-
  - (5) the maximum extraordinary leave which may be granted to Government employee on the basis of completed years of continuous qualifying service, shall be as follows, namely:-
  - (i) for ten years of continuous qualifying service, maximum twelve months;
  - (ii) for twenty years of continuous qualifying service, maximum twenty-four months:
  - (iii) for thirty years or more continuous qualifying service, maximum thirty-six months;

Provided the aforesaid provisions shall not apply to the cases which falls under subrule (2).".

4. In the said rules, in rule 65, in sub-rule (1), for the words and brackets "provided even if this period (i.e. earned leave plus half pay leave) exceeds the period" the words and brackets, "provided this period (i.e. earned leave plus half pay leave) dose not exceed the period" shall be substituted.
